15 rehabilitation tax credit projects approved by the National Park in 2011

The National Park Service (NPS) approved 15 California projects in 2011 as certified rehabilitations. These completed projects were determined to meet the Secretary of the Interior's Standards for Rehabilitation. California ranked 6th in the nation in terms of certified expenses that totaled \$213,143,571.

Building types in 2011 included the rehabilitation of residential units, theaters, military installation structures, office buildings, and mixed use development. Project floor areas ranged from 2,800 SF to 270,000 SF with rehabilitation costs from \$563,728 to just over \$75,000,000. The Office of Historic Preservation reviewed 60 active projects in 11 counties with estimated total rehabilitation costs of over **1 billion** dollars.

In the Federal Fiscal Year 2011, NPS approved 711 projects (Part 3s) nationwide which represented an estimated investment of \$4.88 billion, the second highest in program history. The program continues to be an effective stimulus for economic recovery in older communities with an estimated average number of 78 jobs created per project in FY2011.
