ADDITIONAL DETAILS ABOUT PUBLIC COMMENTS: Please note that when considering comments related to nominations for designation, the Commission can only consider evidence that pertains to whether or not a property meets the criteria for listing in the National Register of Historic Places, the California Register of Historical Resources, or the California Historical Landmarks/Points of Historical Interest programs. The Commission cannot consider social, economic, or environmental considerations when determining if a property meets applicable registration criteria.

The order of comments for nominations under consideration during the Discussion and Action portion on the agenda will proceed as follows: The Commission will first hear from the nominator or designee. The nominator or designee will have ten (10) minutes to speak. The Commission will then hear from the property owner(s) or designee. Each property owner or designee of an individually nominated property will have ten (10) minutes to speak. Each property owner or designee whose property is within the boundaries of a nominated district will have five (5) minutes to speak. Individuals representing local, state, federal, and tribal governments, will each have five (5) minutes to speak. Any member of the general public will have three (3) minutes to speak. Those members of the public aided by a translator will be allocated twice the time otherwise defined. Within this stated order of commenters, those in the room will be heard from first and then those participating via Zoom or telephone.

Those providing comments about nominations that are on Consent or comments related to other matters not pertaining to nominations will each have three (3) minutes to speak.

Presentations and written comments regarding agenda items should be submitted to OHP for **receipt no later than seven (7) days prior to the meeting**. Presentations must not go beyond the allowable time frame for the applicable comment period as detailed at <a href="https://ohp.parks.ca.gov/?page\_id=21372">https://ohp.parks.ca.gov/?page\_id=21372</a>. Presentations and written comments for the August 8, 2025, meeting **received after 9:00 am Friday, August 1, 2025**, may not be available to the Commission in advance of the hearing.
