#### **Historic Context**

Completed in 1958, its period of significance, the Arthur and Kathleen Connell House was determined eligible for listing in the National Register of Historic Places at the local level of significance under Criterion C in the area of Architecture. It was an excellent example of the International Style within the Modern Movement in Pebble Beach, and representative of master architect Richard Neutra's midcentury residential work. The house exemplified the rational design approach associated with Modern architecture, with thoughtful delineations between public and private areas that do not compromise its open, flowing spatial quality. As an outstanding expression of the International Style of Modern architecture by a master architect, the Connell House was a superb contributor to the architectural heritage of Pebble Beach, Monterey County, and northern California.

#### **Current Physical Description**

The house was demolished in February 2024 under Monterey County Permit #15CP01573 with the final permit signed off March 5, 2024.

#### Request

Pursuant to 36 CFR § 60.15 (a)(1), the property owner, Massy Mehdipour, Signal Hill LLC, requests the removal of the Arthur and Kathleen Connell House from the National Register of Historic Places on the grounds that, "The property has ceased to meet the criteria for listing in the National Register because the qualities which caused it to be originally listed have been lost or destroyed."

Evidence of demolition is included in the accompanying August 21, 2025 correspondence from the property owner.
